## **BRANCH AFFILIATIONS**

Please see that your branch is affiliated for the current year. The cost is £50 for established Cumainn and £20 for new ones. The fee hasn't increased for a number of years and given that this time of year, after the Ard Fheis and prior to receipt of income from National Collections, is a particularly lean one — the fees are urgently required.

## **RE-REGISTRATION OF MEMBERS**

While most members re-registered after the Ard Fheis there are still major gaps. Once again it is necessary to repeat that while a Party card doesn't make someone a good member **IF YOU HAVEN'T A PARTY CARD YOU ARE NOT A MEMBER.**

*A show of cards should be mandatory at the commencement of each meeting.*

Stamps cost 50p for employed members and 20p for members working in the home, students and unemployed.

## **ASSOCIATE MEMBERS**

In recent months there has been an upsurge in awareness for the need to bring supporters into association with the Party.

Associate membership is a very positive way to recruit new blood into our ranks. Each branch should have at least fifty people they know who support us.

Their names and addresses should be listed and they should be written to asking them to enrol as supporters of the Party.

Cards are available from Head Office and each constituency should purchase a stock of these (£1 each). All you are required to do is keep a record of their names and addresses.

You will at least need the help of your supporters to make an honest attempt at winning a seat in the next Assembly or Dáil elections.

## **WHAT SHOULD YOU DO WITH YOUR SUPPORTERS' GROUP?**

We suggest each branch bring them together, at least invite them at regular intervals to discuss progress and problems in the community and means to further the effectiveness and influence of our Party. Where we have elected representatives this is crucial.

When you have a speaker from Head Office, a Specialist Committee to your region or wherever, invite them to join you. We must educate our supporters to make members of them.

*We want to make supporters of the electorate and members of our supporters.*

## **COLLECTIONS**

Door-to-door, Church gate and street collections are coming up... notify your supporters of these dates and ask for their help.

In parts of Cork our branches re-direct National Statements which they feel are of particular interest. The response from supporters has been tremendous and they are learning more about us.

It is envisaged to compile a national file of supporters over the coming months so as to send briefings directly to them. You are therefore requested to send on a list from your area as soon as possible.

*Constituency Associations are not places to put lazy members 'out to grass', — they have to be used as a pool from which to recruit and build the Party.*

## WATER RATES

We need to know the up-to-date position on water and other local charges from each constituency.

Please let us know whether the charges have been abolished; who voted and which way; what efforts are being made to collect outstanding charges and where are they being introduced for the first time.

The newly appointed Local Government Environment Committee has been requested to come forward with a programme to deal with the current situation as we know it. This programme will be circulated when available.

For the moment, it appears the situation is as follows: (a) areas have abolished charges but are making heavy demands to collect outstanding charges. (b) Authorities are continuing to levy charges and indeed extending them. (c) Authorities endeavouring to introduce charges.

In reply to (a): We should look for an amnesty and get NATO and ACRA to campaign. Note that many who requested waivers and indeed received them, are being sent bills so they should seek new waivers.

(b): Continue our opposition and ensure it is an issue in the general election. Particularly highlight the hypocrisy of Fianna Fáil.

This is essentially a class issue and we must continue to highlight the failure to collect tax from those who owe it; failure to collect health, employment levies and failure to go after outstanding agricultural rates.

The public must be made aware of our position viz viz the Fianna Fáil coalition and the Fine Gael, Progressive Democrats, Labour coalition.

(c): Where authorities are attempting to introduce charges for the first time the battle is similar to (b). Also highlight the difficulties faced in areas where attempts have been made to effect charges.

We outlined our views on local government finance last June and we must make this our primary, positive point. Each area is in possession of the document outlining our policy, so carry it in Newsletters and leaflets.

WATER RATES

1. We refer to several queries from local residents concerning the latest Water Charges Bills received last week. The position is as follows:
  - (a) Firstly the notice from the County Council is not a Civil Bill or a notice to appear in Court. It is merely a "final notice" except on this occasion, it has issued from the Council's Law Department.
  - (b) If the Local Authorities wish to proceed to Court they will have to select a small number of residents in each area. This has not yet happened.
2. Immediately after the <sup>Local Government Elections (Dublin Corporation)</sup> the Workers' Party put down a motion for the abolition of Water Charges. This unjust tax was duly abolished but only with effect from January 1st 1986.
3. Subsequently Fianna Fail, Fine Gael and the Labour Party (except one Labour Councillor from North Dublin) combined to defeat a Workers' Party motion the purpose of which was to require the County Council not to proceed with the collection of arrears before January 1st 1986 and to terminate any contemplated legal actions against residents refusing to pay this unjust tax.
4. In this connection it is worth recording that when the Fianna Fail Government abolished Farmers Resource Tax in 1982 they actually refunded this tax to farmers who had already paid.
5. We would also draw your attention to Thursday's District Court decision which ruled that Dublin Corporation could not charge for water used during the first six months of 1983 because the legislation was not introduced by the then Minister for the Environment, Dick Spring, until July 1983. In other words as the law now stands the Bills you have just received may be inaccurate.
6. The Workers' Party has consistently opposed this unjust double taxation and we remain convinced that residents are entitled to refuse to pay the arrears. We fully support the position of ACRA and NATO. Further if you have not already applied for a Waiver Form you should do so without delay.

## COPY OF WATER RATES LEAFLETS ISSUED BY DUBLIN WEST

### WATER TAX : Points To Remember

- (1) If you have received a demand for £90 arrears from the Law Department of Dublin County Council you should send it back to them without delay and ask for a waiver form. Remember waiver forms are not just for people on social welfare but for anyone who simply does not have the £90.
- (2) Fill out the waiver form pointing out that payment of £90 would cause you 'serious hardship' and return it to Dublin County Council, Water Charges Section, 7/8, Cavandish Row, Parnell Square, Dublin 1.
- (3) The Council may not eventually accept your argument for non-payment and persue you again for the money. If you still don't pay they may summon you to Court.
- (4) The Court case is a civil one and not a criminal case (i.e. the summons is not served by a Garda but is delivered through the post).
- (5) You don't have to attend the Court if you don't want to. (You will lose the case anyway).
- (6) The Justice will award a decree for £90 plus about £8 costs to the Council against you but it will be up to the Council to collect the money.
- (7) The Council may send the Sheriff to your house to collect the debt. You may sign an affidavit transferring all your possessions to your wife/husband (witnessed by a Peace Commissioner) and hand it to the Sheriff. He will then enter "No Goods" on his form and this will be the end of the matter.

# THE DIVORCE REFERENDUM

In the aftermath of the divorce referendum it would be too easy to dwell on the negative aspects. It is worthwhile therefore, to take a look at the figures and to make some suggestions on where to go from here.

First, it is correct to compare the voters who voted 'no' in 1983 with those who voted 'yes' in 1986. It is also interesting to compare the campaigns and the percentage poll.

*Despite the active opposition to a 'yes' vote by Fianna Fáil, who command 51% according to opinion polls, large and vociferous elements of Fine Gael, a generous portion of Labour — South Kerry et al, the Provos to a large part and the Roman Catholic Church.*

Add this to the passive approach adopted by almost all parties including

the PDs who appeared out of the desert at 6pm on polling day. We have a very formidable force in opposition.

The Workers' Party was the only party with an unequivocal stance on this referendum. Our slogan was "Civil Divorce is a Civil Right" and this is what the campaign should have been fought on.

We campaigned in all but two constituencies in the referendum. We leafletted towns where we do not have an organisation from Tullow to Donegal town. In all, over twenty major towns were leafletted outside of our existing network.

*We helped the Divorce Action Group campaign as far as possible and indeed organised it in many constituencies. We can therefore hold out heads up and be satisfied that the resulting 'yes' vote was in no small part due to our efforts.*

The percentage results:

**DUBLIN** 51% yes, 49% no. **REST OF LEINSTER** 32% yes, 68% no. **MUNSTER** 30% yes, 70% no. **DONEGAL/CAVAN/MONAGHAN** 28% yes, 72% no. **CONNACHT** 28% yes, 72% no. With the poll at 63%, fewer than four out of ten said no of those on the register of electors. One in five citizens who have a right to vote said yes.

*But a more interesting picture is painted when the 1983 'no' votes are compared with the 1986 'yes' vote.*

**34 out of 41 constituencies** showed a greater 'yes' vote than a 'no' vote in 83. There was no change in five constituencies and in only two constituencies, Cork North and South Central, was the 'yes' vote lower than the 'no' vote in 1983.

It is interesting to note that there are Labour TDs in both and a PD (defector) in one. It could also be deduced that the higher poll than 1983 was also a sign that many who wanted to say 'no' in

1983 and who didn't vote made up their own minds this time and came out and said 'yes'.

*From all of this we can say there is an increasing number of people willing to make up their own minds and not be dictated to by their church. This is progress.*

While there has been slow progress we must bear in mind that some of our own supporters voted 'no'. We have no doubt that if the issue had been argued on national terms to them this would not have happened.

It highlights the need for us to educate our supporters to every position we arrive at.

Divorce will be an issue in the next general election and we must ensure that all our supporters understand fully the stand taken.

**From here we must be careful not to dwell solely on any one issue. Unemployment is the biggest problem**

*(see over)*



but, for over 70,000 people trapped in broken marriages, many of whom are no doubt unemployed, divorce will remain a burning issue. We must ensure Fianna Fáil are not left off the hook for their cynical approach to this and just about every other issue.

Look at the people you worked with in DAG and if your branch feels they should be with us ask them to join. See

also that DAG is active in your constituency.

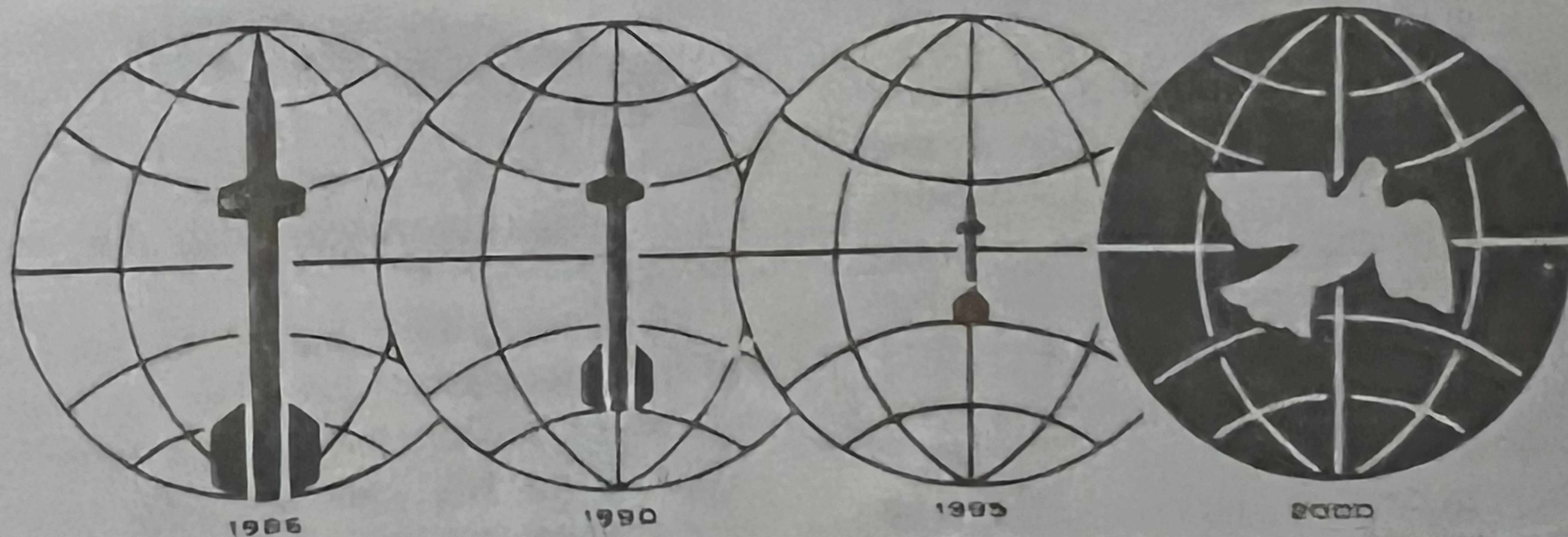
We will continue to demand the separation of church and state but it is important that we don't fall into the trap of a negative, anti-Roman Catholic Church stance.

## TRALEE

Over a number of years many complaints were made to Head Office about Cllr Tommy Foley of Tralee. Members of the Ard Comhairle spoke with him on a number of occasions.

*In early January a serious complaint was made and this was investigated by a committee set up for the purpose. The matter complained of resulted in a court case which brought the Party into disrepute.*

The committee of enquiry reported to the CEC which decided that Cllr Foley should hand over his seat to the Party and failure to do so should result in

dismissal.

*The Management Committee decided to request our members in North Kerry to nominate a replacement should the seat be handed back to the Party.*

The General Secretary and Administrative Secretary travelled to Tralee and notified Tom Foley of the decision. He refused to resign the seat to the Party and was subsequently expelled.

Meetings to re-organise the Party in South and North Kerry have taken place and we look forward to building a solid core in the next general elections in both constituencies.

## SOUTH TIPPERARY

Facts in connection with the resignation of Christy Kinahan, UDC member for Tipperary Town.

Christy Kinahan was admitted into the Party in 1983 after eighteen years in the Labour Party. A number of ex-Labour members were admitted as well. We experienced difficulties in getting the branch to sell *The Irish People* and after a lot of coaxing they commenced sales last October.

We also experienced a lot of problems in getting members registered and stamped up. At the time of his resignation, in March of this year, neither Christy Kinahan nor anyone else in Tipperary Town were registered.

We had been patient as many excuses were given, illness etc. In fact, a Convention organised for February had to be postponed as no one from Tipperary Town was registered. It had also been intimated that Christy Kinahan, contesting South Tipperary as a lone WP candidate would not be acceptable. The role and work of WP candidates was fully outlined and a further Convention was arranged for March.

★ The following was intended for the last issue but was omitted due to lack of space.

In the meantime, Christy Kinahan led Head Office to believe that he was having difficulties with the members in Tipperary due to the Today Tonight programme. In fact *it was he* who was encouraging others to resign and did so himself.

The Convention, scheduled for March 19th, proceeded on the request of members in South Tipperary and Councillor Sean Hill was selected and has since been ratified. The Party is very much alive and well in South Tipperary and all the stronger for the departure of Christy Kinahan. His prospects as a Dáil candidate, it is felt, had a greater bearing on his resignation than any RTE programme.

The aim should be to match sales with first preference votes in each Constituency. There is a role for associates here and in order to make this a reality you will have to involve supporters. Selling papers at employment exchanges and other places of congregation is a must.

There is a gap which is not being filled by *The Irish People* due to its size.

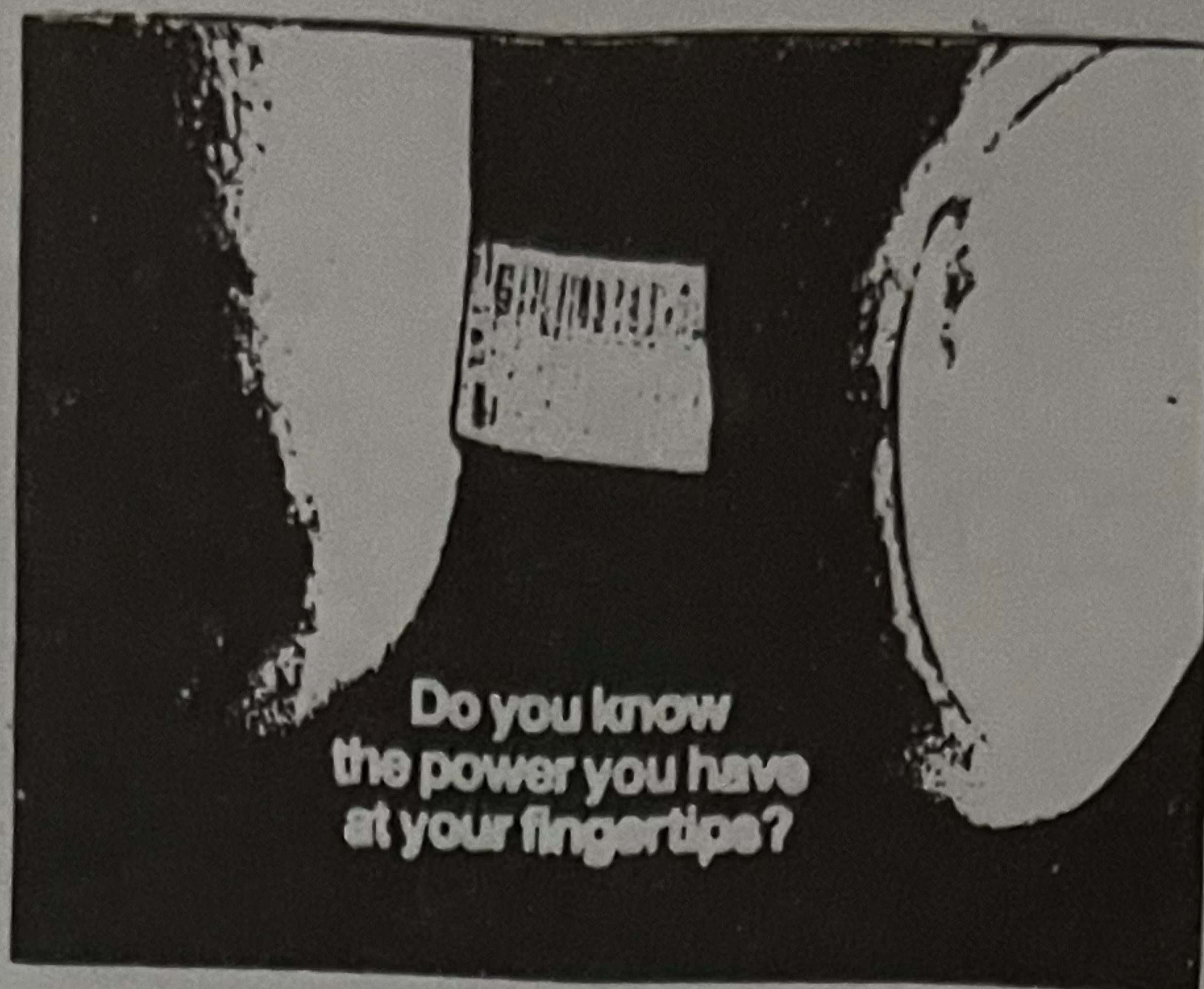

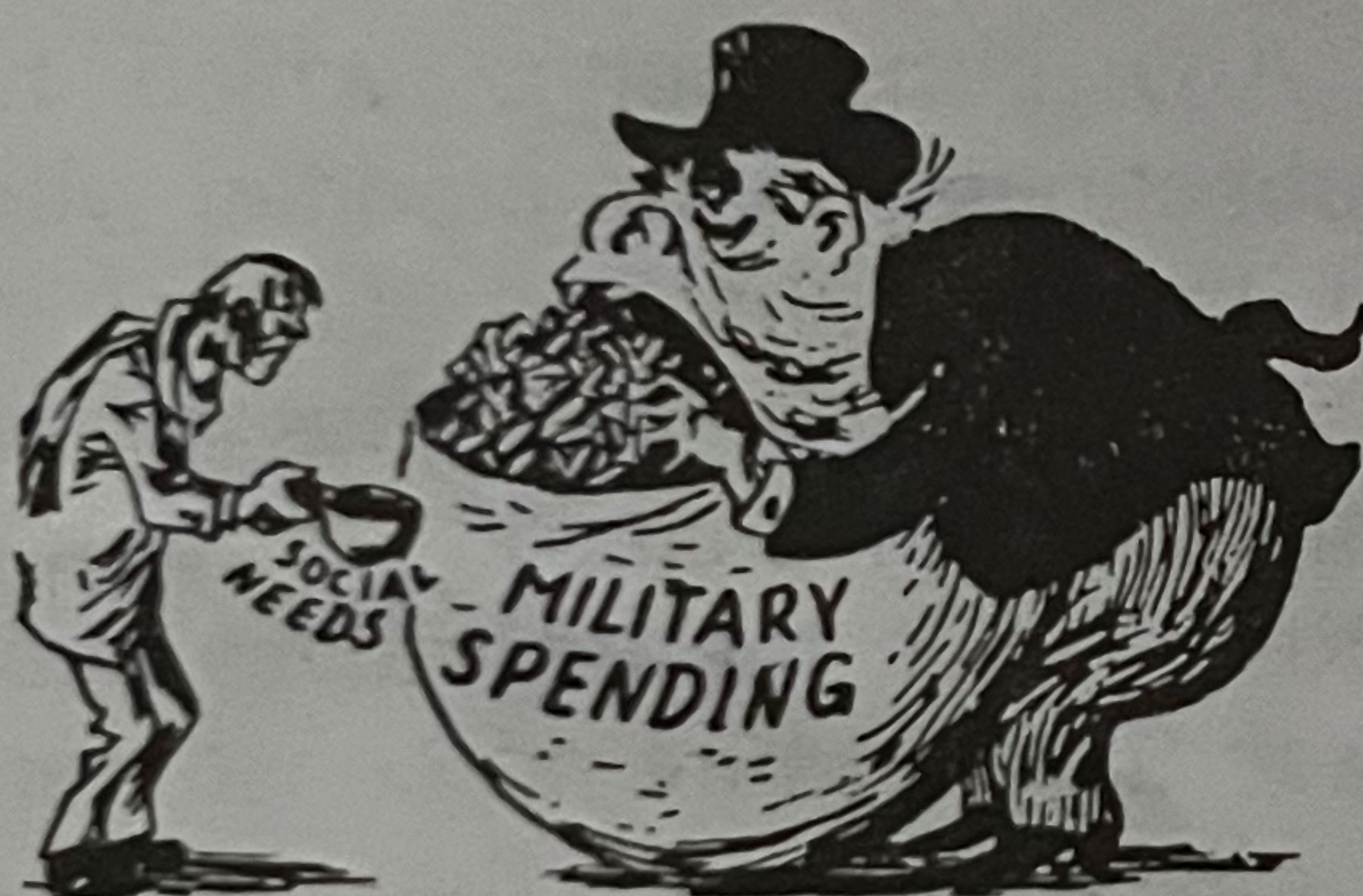


## Application of Science and Technology

At this year's Young Scientists Exhibition held in the RDS, Dublin, Workers' Party Youth gathered signatures on a petition which called on young people "to use the skills they acquire for socially useful production and not for the manufacture of weapons of destruction".  
By signing the petition 260 exhibitors and visitors pledged themselves to the cause of peace.



*In an age where 20% of the world research in science and technology is applied to the military sector and billions spent on armaments, people are dying the world over from hunger and disease.*

*In this country alone we can produce, through the use of microtechnology, guidance apparatus for nuclear missiles, yet people with disabilities, e.g. eye and ear defects, are no better off for all the advances in science.*

We believe that through the proper application of technology many more jobs can be created and many more lives can be saved.

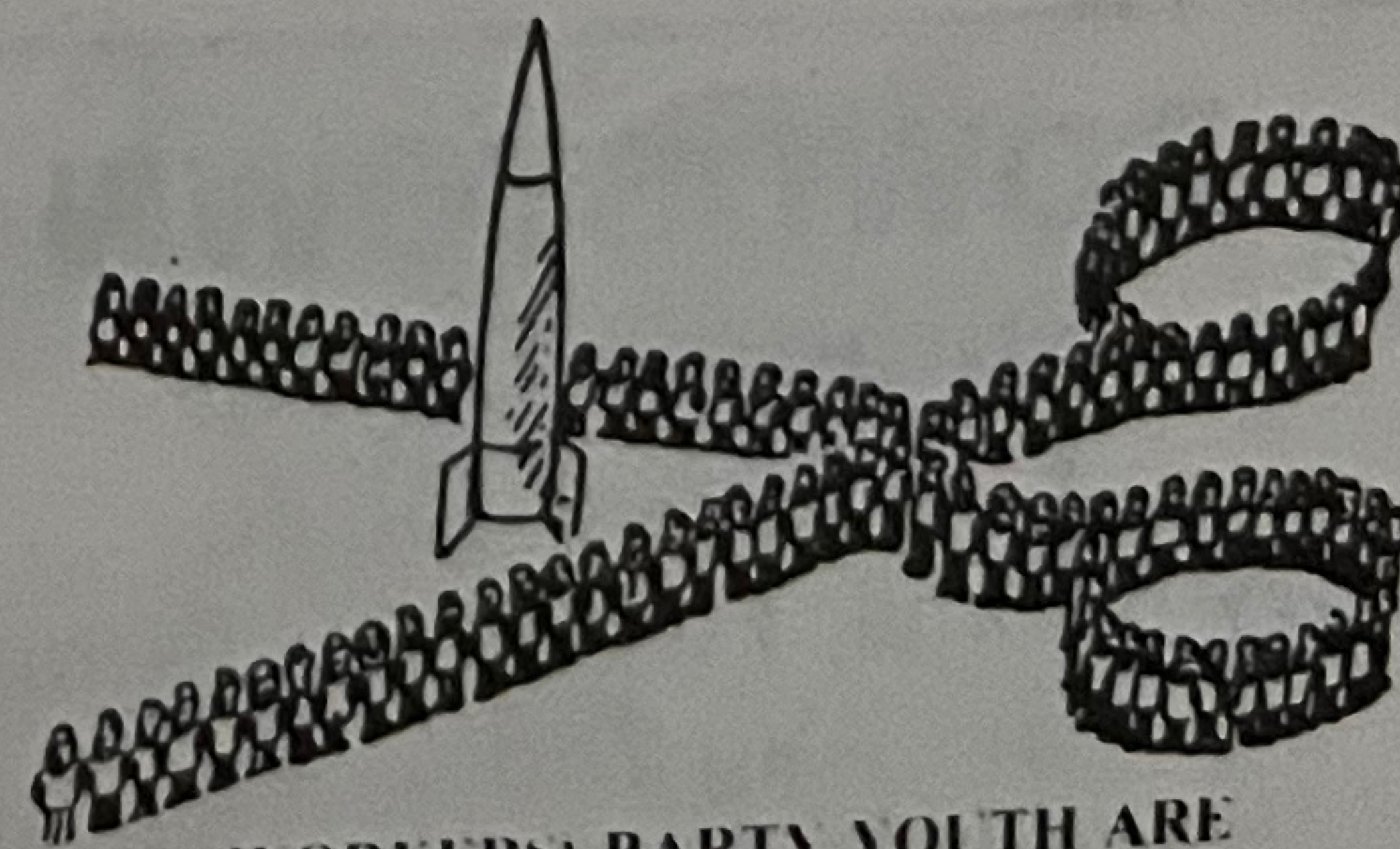
In this International Year of Peace we call on young people who are applying themselves to science and technology to use their skills for the preservation of mankind and not for its destruction.

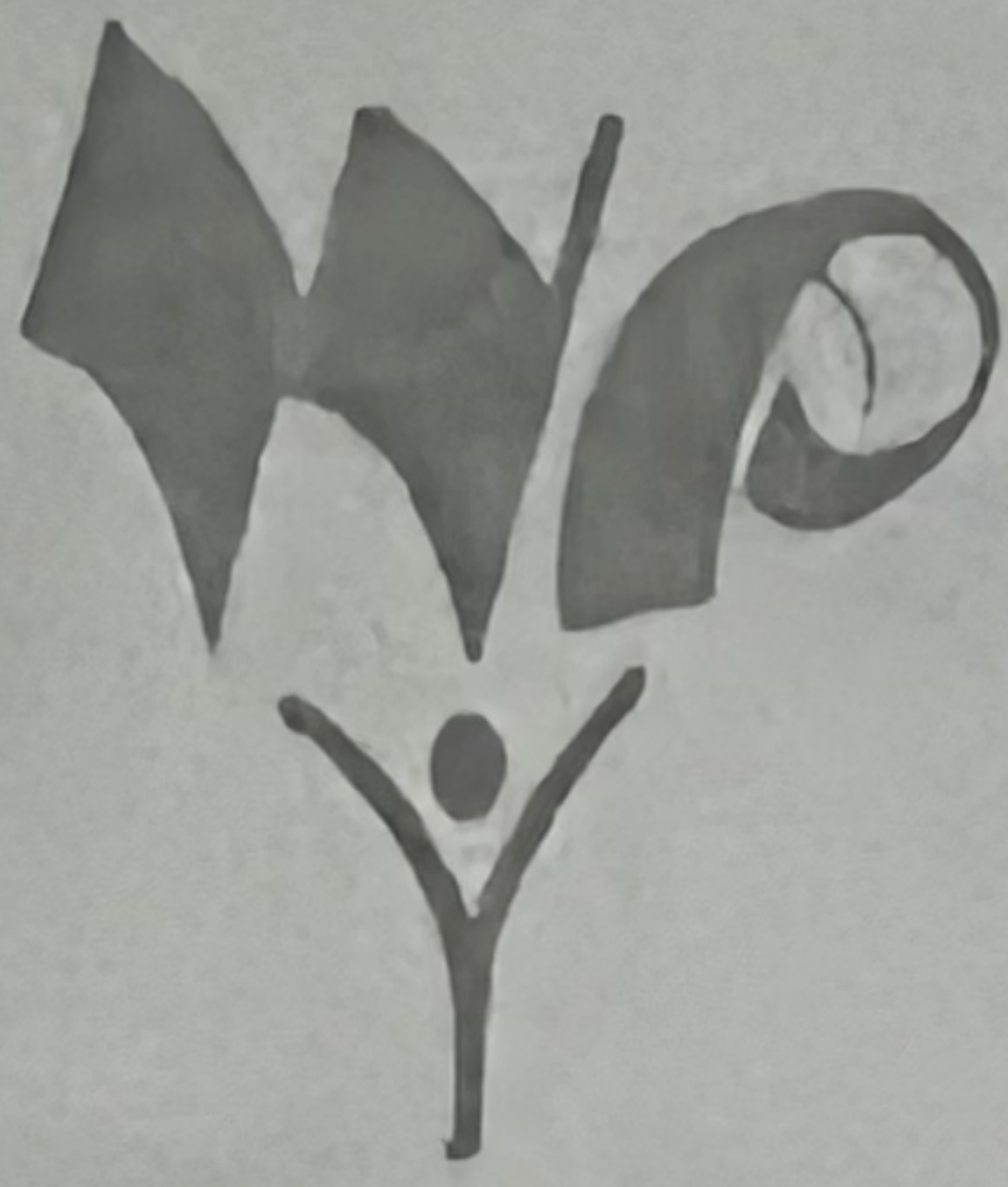

## New Fundraising Venture

The Finance Committee has devised a 300 member limited draw as a major fundraising effort for this year. The draw will take place on a fixed date each month for 12 months.

The subscription is £10 per month paid by bankers order or £100 for a full year paid in advance.

Any constituency which has 6-9 subscribers will be credited with 25% of income from that constituency (e.g. constituency X has  $8 \times £120 = £960$ , therefore that constituency will have £240 credited against its minimum contribution to Head Office).

Any constituency which has 10+ subscribers will be credited with 33 1/3% of its total contribution in the year.

The income from this draw should improve the financial position of Head Office while the incentives should help ease the pressure on constituencies.

Please ensure that all branches, members and supporters in your constituency are fully informed of this major fundraising undertaking.

The prizes are as follows:

1st prize each month: £1,000

4 runner-up prizes of £100 each

This means there are 60 prizes in the full year.

Each subscriber has a 1 in 5 chance of a win. The draw will be carried out under the supervision of at least one of the trustees and the results will be published in the national press.

## Door-to-door collections.

In preparation for the forthcoming General Election door-to-door collections are an important part of our preparation:

1. To distribute a leaflet advertising our policies and candidates.

(2) An invaluable door-to-door canvass — probably the most honest canvass you will ever do.

(3) Recruiting supporters.

(4) Checking that your supporters are on the Register of Electors. This is very important as many people were removed from the Register for the Referendum — you must see that our supporters have votes.

(5) Getting to know people and problems in new areas.

(6) The object of the exercise is to raise money. Last year Killarney raised £400 in their first effort and only covered little over half of the town. Involve supporters and in particular people who are known.
